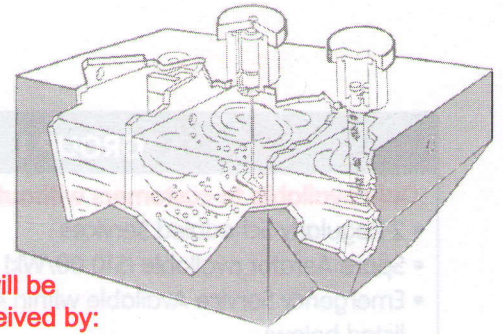

- B) Repair due to Moisture, Flooding, or Freezing, both inside and outside.
- C) Repair due to shorts in wire or improper wiring.
- D) Replacement of any materials not listed as covered under the chosen group plan.

Additional parts or service are to be paid at time of service call.

The homeowner is responsible for notifying Norwalk when the red light is on or audible alarm sounds. The homeowner is responsible to keep access open to all aeration parts. Failure could lead to additional service fees.

Norwalk is not responsible for any wiring inside the house or from the house to the aeration system.

Norwalk is not responsible for sewer line running to or from the unit or problems related to sandfilter failure.

The Homeowner and Norwalk Tank Co. agree to comply with all Local Health Department regulations and will notify the Health Department if the contract has been voided by either party.

If legal action is taken against Norwalk Tank Co. and if found not guilty in complaint, the plaintiff agrees to pay all legal expenses.
