That in the event Buyer fails to make payments for any goods or materials purchased from Seller in accordance with the terms of this contract or contracts of purchase, invoices or purchase orders covering such goods or materials, Guarantor agrees that he will guarantee to Seller, or its assigns, the payment of any and all amounts due on any such purchase presently existing or existing in the future between Seller and Buyer, and the payment on demand of the balance of all said amounts if not paid when due; together with interest at 18% from date of default of Buyer and notice of such default to Guarantor, as hereinafter provided, and all costs and expenses including reasonable attorney's fees which Seller may incur in collecting or attempting to collect any indebtedness from Buyer or from undersigned Guarantor. This guarantee is unconditional and execution hereof by said Guarantor shall be binding upon him, irrespective of any agreements to that effect or otherwise; this guarantee shall be enforceable without Seller, or its assigns, first proceeding against Buyer, or any other person, and Guarantor hereby waives notice of the acceptance of this Guarantee and also waives notice of any default by Buyer with respect to the payment of said due amounts. It is further understood that notice of termination will have no effect on the guaranty in relation to existing indebtedness of Buyer to Seller at time of notice of termination and this guaranty will continue to remain in full force and effect as to any such indebtedness until it is paid in full. It is further understood that there are no conditions or limitations to this undertaking except those contained herein at the time of signing hereof and that after execution no alteration, change or modification shall be made except in writing signed by Seller and Guarantor.
